If you would like to switch plans or discontinue service, you must contact the TAL Office by Friday, June 20, 2024.

\*\*Reminder of our enrollment policy. As of July 1, 2023, once a retired member chooses to join the dental program, whether this be directly following their active service or into their retirement, if they suspend coverage, for any reason and in the future would like to rejoin the dental insurance, they can only do so by joining the DMO program and must remain in that program. Any member who must rejoin dental as a result of the loss of a spouse or partner, can join the dental program in whichever program they'd like.
